We are a wholly owned subsidiary of Focus Financial Partners, LLC ("Focus"), and Focus is a minority investor in UPTIQ, Inc. The range of services offered or expected to be offered by UPTIQ to our advisory clients includes, but is not limited to, omnibus cash management products, individual level deposits, non-purpose securities-backed lines of credit, commercial loans, aircraft and marine loans, non-securities-based/asset-secured loans, and residential mortgage loans. When legally permissible, UPTIQ and Flourish each share a portion of this earned revenue with an affiliate of our firm. The affiliate distributes this revenue to us when we are licensed to receive such revenue (or when no such license is required) and the distribution is not otherwise legally prohibited.
