On February 18, 2026, Tokio Marine Holdings, Inc. (“Tokio Marine”) through its wholly owned subsidiary Delphi Financial Group, Inc. (“Delphi”) acquired a majority stake in ACORE Capital, LP. In connection with this acquisition, Deloitte & Touche LLP completed an independence assessment with respect to the new affiliates of the ACORE Funds under the SEC independence rules and identified that the member firms of Deloitte Touche Tohmatsu Limited and their related entities (collectively, “Deloitte”) provided certain professional services to and had business relationships with Tokio Marine and Delphi that are inconsistent with the auditor independence rules provided in Rule 2-01 of Regulation S-X if provided to an affiliate of an audit client. These services and business relationships were not subject to independence requirements prior to the close of the acquisition and were no longer subject to independence requirements upon the issuance of the audit reports for the year-ended December 31, 2025. After considering all of the relevant facts and circumstances presented, those charged with governance of ACORE Funds and Deloitte concluded that Deloitte was capable of exercising objective and impartial judgment on all issues encompassed within Deloitte’s audits of the ACORE Funds for the year-ended December 31, 2025, and that a reasonable investor with knowledge of all relevant facts and circumstances would not conclude otherwise. Schedule D 7.B.(1) - For all purposes hereunder, including section 7.B(1) of Schedule D, alternative investment vehicles have not been separately reported as a client, and the information regarding each alternative investment vehicle has been aggregated with the private fund to which it relates. ACORE Credit Partners III, LP did not hold funds or securities during the year ended December 31, 2025, and therefore was not subject to audit for such fiscal year.
