BCAM carries out its asset management activity, including the exercise of investment discretion and voting rights, independent of the AMG Affiliates. The AMG Affiliates do not formulate advice for BCAM's clients and do not, in BCAM's view, present any potential conflict of interest with BCAM's clients. Consequently, individual information on each AMG Affiliate is not listed in Section 7.A. of Schedule D of Part 1A of Form ADV, unless BCAM has business dealings with certain AMG Affiliates. A list of all AMG Affiliates is available to BCAM's clients upon request. BCAM is deemed, under the federal securities laws, to have custody of client assets by virtue of its role as general partner of certain limited partnerships or managing member of certain limited liability companies that are pooled investment vehicles (“funds”). BCAM does not have actual physical custody of any client assets or securities invested in by the funds; rather, all such assets are held in the name of each fund by an independent, unaffiliated qualified custodian. The funds are audited annually and fund investors receive annual statements, as required by applicable law.
