Regarding Schedule D, Section 7.A. for VamosVentures GP I, LLC (the “GP Entity”), the Registrant notes that the GP Entity is the general partner to the Registrant’s private fund client. The GP Entity is not filing its own Form ADV but is instead relying on the interpretive guidance outlined in the “Frequently Asked Questions on Form ADV and IARD” on the SEC’s website under the heading “Reporting to the SEC as an Exempt Reporting Adviser.” That guidance essentially permits a GP entity to a private fund to rely on the Form ADV of the fund’s investment adviser. In addition, as an ERA, the Registrant is not subject to Rule 205-3 under the Advisers Act, and it is not currently subject to a state law equivalent, which would require fund investors to be qualified clients.
