ON APRIL 17, 2024, THE PENNSYLVANIA DEPARTMENT OF BANKING AND SECURITIES ALLEGED THAT THE FIRM VIOLATED AN INVESTMENT-RELATED PENNSYLVANIA STATE LAW RELATED TO STATE INVESTMENT ADVISER REGISTRATION BY FAILING TO APPROPRIATELY REGISTER AS A REGISTERED INVESTMENT ADVISER IN PENNSYLVANIA. THE FIRM MAINTAINS THAT A VIOLATION DID NOT OCCUR, THAT THE FIRM WAS SUBJECT TO A REGISTRATION EXEMPTION IN PENNSYLVANIA DURING THE RELEVANT PERIOD, AND THE FIRM APPROPRIATELY INITIATED ITS REGISTRATION IN THE COMMONWEALTH AND DID NOT VIOLATE THE RULE.
