Effective April 7, 2025, Mark Headley, co-founder and member of the firm’s Board of Directors since April 2009, has been appointed Executive Chairman and interim Chief Executive Officer, succeeding Cooper Abbott, who left the firm on that date. Schedule A (Direct Owners and Executive Officers) has been amended accordingly to reflect Mark Headley’s additional titles and roles. Matthews announced on February 13, 2026 that it is in the process of making certain changes to its ownership structure (the "Transaction"). As part of the Transaction, Matthews will repurchase the ownership interests held by three existing investors, RBC USA HoldCo Corporation, Mizuho Bank, Ltd., and affiliates of Lovell Minnick Partners LLC. Those repurchases will be funded, in part, by the purchase of additional equity interests in Matthews by G. Paul Matthews, the founder of Matthews, Mark W.
