THE FUND'S OFFERING DOCUMENTS AND OTHER MATERIALS PROVIDED TO PROSPECTIVE INVESTORS CLAIMED THAT THE FUND SOUGHT TO "GENERATE ATTRACTIVE RISK-ADJUSTED RETURNS ACROSS ALL MARKET ENVIRONMENTS WHILE PRESERVING CAPITAL," AND THAT THE FUND "UTILIZE[D] A FUNDAMENTAL LONG/SHORT EQUITY APPROACH THAT TARGETS A LOW NET EXPOSURE AS ITS PRINCIPAL INVESTMENT STRATEGY." ADDITIONALLY, THE SEC FOUND PCTA ENGAGED IN PRINCIPAL TRADES WITH ADVISORY CLIENTS WITHOUT PROVIDING THE REQUISITE TRANSACTION-SPECIFIC NOTICE OR OBTAINING CONSENT. PCTA ALSO DID NOT ADOPT AND IMPLEMENT WRITTEN COMPLIANCE POLICIES AND PROCEDURES REASONABLY DESIGNED TO PREVENT VIOLATIONS OF THE FEDERAL SECURITIES LAWS IN CONNECTION WITH THE PRINCIPAL TRADES. LASTLY, PCTA DID NOT ADOPT WRITTEN COMPLIANCE POLICIES AND PROCEDURES REGARDING VOLATILITY-LINKED EXCHANGE-TRADED PRODUCTS, WHICH RESULTED IN PCTA'S INVESTMENT ADVISER REPRESENTATIVES ("IARS") USING THEIR DISCRETIONARY AUTHORITY OVER CLIENT ACCOUNTS TO BUY AND HOLD COMPLEX LEVERAGED EXCHANGE FUNDS ("LEVERAGED ETF") FOR RETAIL CLIENTS FOR TIME PERIODS THAT WERE INCONSISTENT WITH THE PURPOSE OF THE PRODUCT AS DESCRIBED IN ITS OFFERING MATERIALS. AS A RESULT, THE SEC STATED WILLFUL VIOLATION OF SECTION 17(A)(3) OF THE SECURITIES ACT, SECTIONS 206(2), 206(3), 206(4) AND RULES 206(4)-7 AND 206(4)-8 THEREUNDER OF THE ADVISERS ACT AND, CENSURED PCTA, AND BARRED MILLER FROM ACTING AS A BROKER OR INVESTMENT ADVISER OR OTHERWISE ASSOCIATING WITH FIRMS THAT SELL SECURITIES OR PROVIDE INVESTMENT ADVICE TO THE PUBLIC. PCTA WAS ORDERED TO PAY DISGORGEMENT OF \$3,054.74, PREJUDGMENT INTEREST OF \$759.35, AND CIVIL PENALTIES OF \$135,000 TO THE SEC. MILLER WAS ORDERED TO PAY \$65,000 IN CIVIL PENALTIES TO THE SEC. MILLER CONTROLLED PCTA'S OPERATIONS DURING THE TIME PERIOD RELEVANT TO THIS ACTION, AND HE WAS ORDERED TO DIVEST HIS INTERESTS IN AND TO HAVE NO RESPONSIBILITIES WITH PCTA AND OTHER REGULATED ENTITIES.
