JUNG, THE WRITTEN AGREEMENT STATES THAT THE ANNUAL RATE WAS 0.80%, AND MR. JUNG CLAIMS THAT THE VERBALLY AGREED RATE WAS 0.75% BUT REFUNDED THE CLIENT ALL FEES COLLECTED ABOVE 0.70%.
