ACCORDING TO THE SEC'S COMPLAINT, THE ALLEGED OVERVALUATION BEGAN IN 2016 AND ALLOWED WEST MOUNTAIN TO RECORD A COLLECTIVE UNREALIZED GAIN OF \$18.6 MILLION FOR THE TWO FUNDS AND THEREBY COLLECT AN ADDITIONAL \$900,000 IN MANAGEMENT AND PERFORMANCE FEES.
