IN ACCORDANCE WITH THE FIRM'S SUCCESSION PLAN, MR. ROBERTS' RESPONSIBILITIES WERE ASSUMED BY GWK'S CO-CEO, MR. THOMAS F.X. POWERS. MR. POWERS BECAME THE FIRM'S SOLE CEO ON JANUARY 1, 2026. ON MARCH 3, 2026, MICHAEL CLARE WAS PROMOTED TO PRESIDENT OF GW&K. IN THIS ROLE, HE LEADS THE FIRM'S STRATEGIC PRIORITIES AND WILL OVERSEE SALES, MARKETING, CLIENT SERVICE, AND DISTRIBUTION, WHILE CONTINUING TO SERVE ON THE GWK MANAGEMENT COMMITTEE AND REPORTING TO CEO THOMAS F.X. POWERS. MR. CLARE JOINED GW&K IN 2010 TO ESTABLISH AND LEAD THE FIRM'S INSTITUTIONAL BUSINESS CHANNEL AND BECAME A PARTNER IN 2018. HE PREVIOUSLY OVERSAW GLOBAL BUSINESS DEVELOPMENT, CONSULTANT RELATIONS, AND RELATIONSHIP MANAGEMENT. UNLESS OTHERWISE NOTED, ALL DATA PROVIDED IN THIS FORM ADV IS AS OF DECEMBER 31, 2025.
