When legally permissible, UPTIQ shares a portion of this earned revenue with an affiliate of our firm. The affiliate distributes this revenue to us when we are licensed to receive such revenue (or when no such license is required) and the distribution is not otherwise legally prohibited. Our affiliate, Focus Risk Solutions ("FRS"), makes referrals to licensed insurance brokers who advise clients regarding insurance matters and place policies on clients' behalf with insurance carriers. For policies placed with insurance carriers on behalf of referred clients, FRS receives a portion of the revenue earned by such insurance brokers from serving our clients.
