Item 15(b) of Section 7.B.1 - Although certain investors that are not qualified clients may be admitted to Registrant clients that rely on section 3(c)(1) of the Investment Company Act, those investors are not charged performance-based fees. Sections 7.B and item 8.b.2 - Registrant's clients also form co-investment vehicles managed by the general partner thereof to provide co-investment opportunities to limited partners and other strategic partners of the funds, as well as to third parties.
