Endnote to Schedule A: Mary Pugh, the firm’s founder and chair of the Board of Directors, owns more than 25% and less than 50% of the total outstanding stock of the firm. The founder’s adult son and daughter are employees and owners of the firm. When aggregated, the shares owned by the founder and the founder’s son and daughter are less than 50% of the total outstanding stock of the firm. Under the Shareholders’ Agreement between all of the firm’s shareholders, the founder has been appointed as each shareholder’s proxy with the right to represent and vote on behalf of all shareholders regarding the size and composition of the firm’s Board of Directors. In the event of the founder’s death or disability, the Shareholders’ Agreement provides that the control over the founder’s shares and these voting provisions reverts to the firm’s co-founder who is a member of the firm’s Board of Directors and Chair of the Board’s Finance Committee. In the event he is unable to perform that role, such proxy rights revert to the founder’s son. Lastly, pursuant to the Shareholders’ Agreement, the founder and her heirs are afforded certain voting or veto rights over matters pertaining to any change of control of the firm, dissolution of the firm, or similar actions. Most of the rights described above only apply to the extent that the founder and her heirs own at least 25% of the issued and outstanding stock of the firm.
