WITHOUT ADMITTING OR DENYING ANY LIABILITY, CATALYST AGREED TO THE SETTLED ORDER, WHICH ASSERTS THAT THE ALLOCATION OF CERTAIN LEGAL FEES BETWEEN CATALYST AND THE MUTUAL FUND SERIES TRUST CONSTITUTED A JOINT ARRANGEMENT THAT REQUIRED PRIOR APPROVAL FROM THE SEC, AND ABSENT THAT APPROVAL VIOLATED SECTION 17(D) AND RULE 17D-1 OF THE INVESTMENT COMPANY ACT AND SECTION 206(2) OF THE ADVISERS ACT. THE LEGAL FEES WERE INCURRED IN CONNECTION WITH REGULATORY INQUIRIES AND PRIVATE CIVIL LITIGATION REGARDING LOSSES SUFFERED BY THE CATALYST HEDGED FUTURES STRATEGY FUND ("FUND") BETWEEN DECEMBER 2016 AND FEBRUARY 2017, ALL OF WHICH WERE RESOLVED FOLLOWING A FEDERAL COURT'S DISMISSAL OF ONE OF THE PRIVATE LITIGATIONS IN JUNE 2019 (DOCKET #2:17-CV-02565; U.S. E.D.N.Y.) ON THE GROUNDS THAT THERE WERE NO ACTIONABLE MISREPRESENTATION OR OMISSIONS. THE REGULATORY INQUIRIES AND PRIVATE LITIGATIONS INVOLVED OVERLAPPING FACTS AND LEGAL ISSUES AFFECTING BOTH CATALYST AND THE TRUST; AS A RESULT, THE TRUST'S INSURANCE POLICY INITIALLY COVERED MUCH OF THE LEGAL COSTS INCURRED BY THE TRUST AND CATALYST, WHICH COSTS CATALYST BOOKED AS A LIABILITY AND INTENDED TO PAY BACK FOLLOWING A FINAL ALLOCATION OF COSTS BY THE INSURANCE COMPANY, WHICH ULTIMATELY TOOK MORE THAN FOUR YEARS TO COMPLETE. OVER TIME, CATALYST REPAID SUBSTANTIALLY ALL OF THE LEGAL FEES ALLOCATED TO IT BY THE INSURANCE CARRIER, EXCEPT FOR \$183,757, WHICH REPRESENTED THE DIFFERENCE BETWEEN THE INSURER'S FINAL ALLOCATION AND THE TRUST'S EARLIER ALLOCATION; THIS AMOUNT HAS NOW BEEN PAID.
