Item 8.C(3) and Item 8.C(4) Blue Road has discretionary authority to select investment banks and other intermediaries to act on behalf of client funds in connection with the sale of portfolio companies. Such firms are typically engaged to manage sale processes and are compensated by the client funds in connection with those engagements. Blue Road negotiates the terms of these engagements, including fee arrangements, on behalf of client funds. Section 7.B.(1) and Schedule D, Section 7.B.(1): Fund-of-Funds Reporting Methodology Blue Road continues to use

an interpretive methodology for identifying fund-of-funds investors in its private funds, consistent with SEC guidance and based on a substance-over-form approach. Under this approach, Blue Road does not treat as fund-of-funds those private fund investors that invest exclusively for their own benefit, such as family offices or proprietary investment vehicles, provided they have no third-party investors, no fiduciary or regulatory obligations to outside parties, and have represented in their subscription materials that they are not a fund-of-funds. In contrast, Blue Road treats as fund-of-funds any private fund investor that pools third-party capital, has fiduciary or regulatory obligations to those third parties, and allocates capital into pooled investment vehicles advised by Blue Road or other managers, even if such investor self-identifies otherwise in its subscription materials. This methodology reflects Blue Road’s good-faith interpretation of applicable regulatory expectations and is intended to align reporting practices with the economic substance of an investor’s activities.
