ACCORDING TO THE ORDER, THE SEC FOUND THAT, FROM APPROXIMATELY JUNE 2020 THROUGH OCTOBER 2023, ONE OAK AND ONE OF ITS INVESTMENT ADVISER REPRESENTATIVES, MICHAEL DEROSA, FAILED TO ADEQUATELY DISCLOSE ADVISORY FEES TO CERTAIN CLIENTS CONVERTING THEIR BROKERAGE ACCOUNTS AT AN UNAFFILIATED BROKER-DEALER TO ADVISORY ACCOUNTS AT ONE OAK (THE "CONVERTED ACCOUNTS") AND DID NOT CONDUCT MEANINGFUL REVIEWS OF THE CLIENTS' INVESTMENT PROFILES OR THE CHARACTERISTICS OF THE TWO ACCOUNT TYPES. IN ADDITION, ONE OAK HAD COMPLIANCE DEFICIENCIES RELATED TO THE CONVERTED ACCOUNTS AND DID NOT PROVIDE A FORM ADV AT THE TIME OF ACCOUNT OPENING. AS A RESULT, THE SEC DETERMINED THAT: (I) ONE OAK WILLFULLY VIOLATED ADVISERS ACT SECTIONS 204, 206(2), AND 206(4) AND RULES 204-3 AND 206(4)-7 THEREUNDER; AND (II) DEROSA WILLFULLY VIOLATED SECTION 206(2) OF THE ADVISERS ACT.
