The Registrant changed its name (from "First Infrastructure Capital Advisors" to "FIC Partners Management") and entity type (from LLC to LP) effective June 1, 2025. In considering whether change of entity type constituted a conversion or succession, the Registrant relied on the state law of formation and SEC guidance (SEC Release No. 34-31551, IA-1357 (Dec. 28, 1992). Under Delaware law, the Registrant did not experience a succession but rather a conversion pursuant to § 17-217 of the Delaware Code. By converting the Delaware limited liability company to a Delaware limited partnership, the Registrant was not deemed to dissolve under Delaware law and its operations under the Delaware statute were not deemed to be a de facto creation of a new legal entity. Instead, the new LP entity is recognized as a continuation in all respects of the prior LLC entity. Further, under SEC guidance, the Registrant was not succeeded by "an unregistered entity that assume[d] and continue[d] the business of a registered investment adviser that cease[d] its advisory activities." The Registrant is continuing its business as the registered investment adviser.
