Items 5.D.(3)(f) and (g), 9.A.(2)(a) and 9.B.(2)(a): In calculating the dollar value of its assets under management for purposes of Items 5.D.(3)(f) and (g), and 9.A.(2)(a), and 9.B.(2)(a), the Registrant has included only amounts invested in infrastructure assets advised by the Registrant, and has not included any uninvested capital from the OMERS primary pension plan or Co-Investors.
