KARMEL CAPITAL LLC ("KCLLC") IS THE GENERAL PARTNER OF FFII AND SERVED AS THE INVESTMENT ADVISER FOR FFII UNTIL KCM REPLACED KCLLC. KCM IS PARTIALLY OWNED OR INDIRECTLY OWNED BY SCOTT NEUBERGER AND JAMES BRAILEAN. KCLLC IS WHOLLY OWNED OR INDIRECTLY OWNED BY SCOTT NEUBERGER AND JAMES BRAILEAN. IN OCTOBER 2018, FFII SOLD LIMITED PARTNER INTERESTS TO AN INVESTOR LOCATED IN TENNESSEE (THE "TN SECURITIES TRANSACTION"). IN JANUARY 2019, FFII MADE A "BLUE SKY" FILING WITH THE STATE OF TENNESSEE (THE "STATE"). HOWEVER, THE BLUE SKY FILING WAS NOT FILED IN A TIMELY MANNER.
