FIRST, DURING THE PERIOD 1/1/2013 THROUGH 3/1/2017, SPC PURCHASED, RECOMMENDED, OR HELD FOR ADVISORY CLIENTS MUTUAL FUND SHARE CLASSES THAT CHARGED 12B-1 FEES INSTEAD OF LOWER-COST SHARE CLASSES OF THE SAME FUNDS FOR WHICH ADVISORY CLIENTS WERE ELIGIBLE. SPC RECEIVED 12B-1 FEES DIRECTLY FROM ITS THIRD-PARTY CLEARING BROKER IN CONNECTION WITH THESE INVESTMENTS. THE AGREEMENT PROVIDED THAT LOWER-COST MUTUAL FUND SHARES THAT DID NOT CARRY A 12B-1 FEE WERE INCLUDED IN CHARGEABLE ASSETS, WHILE MORE EXPENSIVE 12B-1 FEE-PAYING MUTUAL FUND SHARES WERE NOT. BY INVESTING CLIENTS IN SHARE CLASSES THAT PAID 12B-1 FEES, SPC AVOIDED PAYING AN ASSET-BASED FEE TO THE CLEARING BROKER. SPC FAILED TO DISCLOSE THIS CONFLICT OF INTEREST IN ITS FORM ADV FILINGS OR ELSEWHERE.
