ON AUGUST 31, 2017, THE SECURITIES AND EXCHANGE COMMISSION ("SEC") FILED A LAWSUIT IN THE U.S. DISTRICT COURT FOR THE DISTRICT OF MASSACHUSETTS ALLEGING THAT NAVELLIER & ASSOCIATES, INC. ("NAI") AND LOUIS NAVELLIER ("LN") EACH ALLEGEDLY VIOLATED SECTIONS 206(1), 206(2), AND 206(4) OF THE INVESTMENT ADVISORS ACT OF 1940 AND RULE 206(4)-1(A)(5); AND ALTERNATIVELY, THAT LOUIS NAVELLIER ALLEGEDLY AIDED AND ABETTED NAI'S ALLEGED VIOLATIONS. NAI AND LOUIS NAVELLIER EACH STRENUOUSLY DENY THAT THEY COMMITTED THE ALLEGED VIOLATIONS. THE SEC CHARGES BASICALLY THAT NAI'S VIREO MARKETING MATERIALS SUPPOSEDLY FALSELY CLAIMED THAT NAI'S VIREO ALPHASECTOR STRATEGIES WERE LIVE TRADED SINCE 2001. NAI'S VIREO MARKETING MATERIALS MADE NO SUCH CLAIM. THE STATEMENT NAI ACTUALLY DISSEMINATED WAS TRUE. THE SEC ALSO ASSERTED THAT NAI AND MR. NAVELLIER DID NOT HAVE "SUPPORT" FOR THE STATEMENT NAI MADE. HOWEVER, NAI DID HAVE SUPPORT FOR ITS TRUE STATEMENT FROM NASDAQ OMX AND FROM JAY MORTON. DESPITE THE SEC'S LACK OF ANY EVIDENCE, THE DISTRICT COURT GRANTED PARTIAL SUMMARY JUDGEMENT IN FAVOR OF THE SEC, HOLDING THAT NAI AND MR. NAVELLIER VIOLATED SECTIONS 206(1) AND 206(2).
