One civil case remains pending involving NS Management Ltd ("the Company") as a co-defendant. The Company was summoned before the Luxembourg Courts (along with two other defendants) by a former client under a discretionary portfolio mandate with respect to losses caused by investments on behalf of the client in a Madoff related investment product and all co-defendants have filed a motion to dismiss. A court decision on the motion to dismiss based on the incompetency of the Luxembourg Courts and lack of standing of the claimant was to be rendered after the court hearing scheduled for 22 April, 2020. The ensuing Covid pandemic delayed court proceedings for a substantial period of time and hearings were postponed and a certain number of written briefs

were filed by the various parties to the case in court. A court decision was expected mid-2023, but the plaintiff’s lawyer subsequently requested an additional exchange of briefs with respect to the motion to dismiss issue which were granted by the court. The court, by decision dated November 11, 2024 summoned the plaintiff to deposit a caution of Euro 29’623, without entering into discussion with respect to the motion to dismiss described above. On 5th June, 2025, the Claimant renounced to deposit the monetary guarantee but is noted that the statute of limitations in relation to the proceeding expires 3 years from the date of the last court decision, this being due 10th November, 2027 where the case will be definitively and irrevocably removed from the docket at the date.
