BPFP DID NOT RECEIVE THE DEFICIENCY LETTERS AND ERRONEOUSLY PRESUMED THE REGISTRATION WAS COMPLETE. ON NOVEMBER 5, 2020, THE DIVISION SENT A THIRD DEFICIENCY LETTER, TO WHICH BPFP PROMPTLY RESPONDED. IN ACCORDANCE WITH THE CONSENT ORDER, BPFP PAID A CIVIL MONETARY PENALTY OF \$2,500, AND PAID UNPAID REGISTRATION FEES FOR 2020 AND 2021 IN THE AMOUNT OF \$750. UPON THE EXECUTION OF THE CONSENT ORDER AND PAYMENT OF THESE AMOUNTS, BPFP'S REGISTRATION WAS APPROVED AND IS CURRENTLY IN GOOD STANDING. TO SUMMARIZE, THE PRIMARY ISSUE WAS BPFP EMPLOYED AN IAR IN MARYLAND WHO PERFORMED ADVISORY SERVICES BEFORE BPFP WAS OFFICIALLY REGISTERED WITH THE STATE. THE DIVISION DID NOT INDICATE THAT ANY CLIENTS WERE HARMED DUE TO THIS DEFICIENCY.
