Tetragon Financial Management LP ("TFM") serves as the investment manager of Tetragon Financial Group Limited ("Tetragon"), a Guernsey closed-ended investment company whose non-voting shares are listed on Euronext in Amsterdam, a regulated market of Euronext Amsterdam N.V. under the ticker symbol "TFG NA" and also traded on the Specialist Fund Segment of the main market of the London Stock Exchange under the ticker symbols "TFG LN" and "TFGS LN". Tetragon owns Tetragon Partners L.P. ("Tetragon Partners") (formerly TFG Asset Management L.P.) an SEC-registered investment adviser (SEC file number: 801-74150; CRD number: 156040). Please refer to Tetragon Partners L.P.'s Form ADV for disclosures that are relevant to Tetragon Partners' business. Tetragon, a client of TFM, invests in other private funds that are managed by related persons of TFM and Tetragon Partners. TFM does not have any of its own employees. However, a number of employees of Tetragon Partners, an affiliate of TFM, dedicate a portion of their time and efforts to providing services (which include investment advisory services) to TFM and are described in response to Item 5. As previously indicated, Tetragon's non-voting shares are publicly-traded on the Euronext in Amsterdam, a regulated market of Euronext Amsterdam N.V. and also traded on the Specialist Fund Segment of the main market of the London Stock Exchange. This generally precludes Tetragon from identifying its beneficial owners and therefore we cannot provide the information requested in questions 15 and 16 of Section 7.B.1 of Schedule D. Moreover, our response to question 13 of Section 7.B.1 of Schedule D reflects the total number of Tetragon's registered shareholders (which includes Euroclear Nederland with respect to which we have limited visibility) according to Tetragon's share registry as of December 31, 2025. Our response to question 14 of Section 7.B.1 of Schedule D excludes Long Term Incentive Program (LTIP) equity-based awards that are intended to be given to certain senior employees that are held in escrow. Notwithstanding the foregoing, the Tetragon share ownership of the TFM principals, directors and other Tetragon/Tetragon Partners employees is included in the response to question 14 of Section 7.B.1 of Schedule D. Similarly, our responses to questions 19 and 20 of Section 7.B.1 of Schedule D excludes certain clients of Tetragon Partners that may invest in Tetragon's publicly traded shares as such investments are made by a client of another registered investment adviser notwithstanding the affiliation of TFM and Tetragon Partners. An indirect owner listed in Schedule B, AEJ Holdco Ltd., is a foreign entity that does not have an employer identification number or IRS tax identification number.
