The range of services offered or expected to be offered by UPTIQ to our advisory clients includes, but is not limited to, omnibus cash management products, individual level deposits, non-purpose securities-backed lines of credit, commercial loans, aircraft and marine loans, non-securities-based/asset-secured loans, and residential mortgage loans. When legally permissible, UPTIQ and Flourish each share a portion of this earned revenue with an affiliate of our firm.
