****Regarding Items 5.A. and 5.B. (Employees), the Adviser is party to an arrangement with ACON Investments, L.L.C. ("ACON Investments"), pursuant to which ACON Investments provides the services of various private equity fund investment, finance, accounting, tax, legal, ESG, investor relations, compliance and support professionals to the Adviser. Most of the employees and independent contractors that work with ACON Investments are not engaged by the Adviser directly.
