The affiliate distributes this revenue to us when we are licensed to receive such revenue (or when no such license is required) and the distribution is not otherwise legally prohibited. Our affiliate, Focus Risk Solutions ("FRS"), makes referrals to licensed insurance brokers who advise clients regarding insurance matters and place policies on clients’ behalf with insurance carriers. For policies placed with insurance carriers on behalf of referred clients, FRS receives a portion of the revenue earned by such insurance brokers from serving our clients. The amount of insurance commission revenue earned by FRS is considered for purposes of determining the amount of additional compensation that certain of our financial professionals are entitled to receive. In accordance with the SEC’s “no action letter” of clarification of the Custody Rule dated February 15, 2017 concerning standing letters of authorization for third-party transfers, the firm has reported the applicable information in ADV Part 1, Item 9. Further, the firm is not subject to a surprise examination due to the adherence of the seven safeguarding circumstances outlined in the “no action letter”.
