(1). This Firm practices periodic and regularly scheduled client reviews. Each review is scheduled and then at the completion of that review, the next review is automatically scheduled with the client. There is always a scheduled review meeting for every client on the firms' and the client's calendar. Preparation for each review would include portfolio analysis, rebalancing, restructuring and trades as needed. These services only occur in preparation for a client review. Between schedule reviews, if the client initiates a request or the custodian requires some action, then these services may be applied. Between client reviews there are no ongoing supervisory or management services initiated by the Firm. (2). The Firm's Contract and IPS, has no reference to continuous and regular supervisory or management services. Frequency is referred to as "Periodic" and stipulates that quarterly reports may be issued by the Custodian. Periodic is exactly how the Firm's service model is fulfilled.
