TOGETHER WE HIRED SEVERAL THIRD PARTY MONEY MANAGERS TO OVERSEE A BALANCED INVESTMENT APPROACH WHILE TOGETHER MANAGINE THE FIXED INCOME PORTFOLIO. IN 1997-98 CENEX AND LAND 0 LAKES FORMED A JOINT VENTURE MERGING SEVERAL DEPARTMENTS. THE LEGAL DEPARTMENT, AND MY

PRIMARY CONTACT WAS EFFECTED. NOT HAPPY WITH THE OUTCOME MY CONTACT DECIDED TO LEAVE AFTER NEARLY 30 YEARS OF SERVICE. IN DOING SO HE OPENED UP THE DOOR TO A HOST OF CHANGES, WHICH INCLUDED CHANGING INVESTMENT FIRMS AND MANAGERS. DURING THIS TIME I MOVED MY PRACTICE TO PRUDENTIAL SECURITIES.
