ON 11 JUNE 2020, THE FCA PUBLISHED A FINAL NOTICE IMPOSING A PENALTY OF £64,046,800 ON LLOYDS BANK PLC, BANK OF SCOTLAND PLC, AND THE MORTGAGE BUSINESS PLC ('THE BANKS') FOR BREACHES OF PRINCIPLES 3 AND 6 OF THE AUTHORITY'S PRINCIPLES FOR BUSINESSES. THESE BREACHES WERE IN RELATION TO THE HANDLING OF MORTGAGE CUSTOMERS IN PAYMENT DIFFICULTIES OR ARREARS BETWEEN 7 APRIL 2011 AND 21 DECEMBER 2015. AS A RESULT OF THESE BREACHES, THE FCA FOUND THAT THE BANKS PUT A LARGE NUMBER OF CUSTOMERS AT RISK OF BEING TREATED UNFAIRLY.
