In connection with its ability to directly debit fees from client accounts, the Advisor implements safeguards. Concurrently with such debiting of fees, Rhubarb will provide the Client an invoice or statement itemizing the fee, including the formula used to calculate the fee, the value of the assets under management on which the fee is based, and the time period covered by the fee. Clients will be provided with a statement, at least quarterly, from the Custodian reflecting deduction of the advisor’s fees. Rhubarb Investments strongly urges clients to review their brokerage statement to verify the accuracy of the calculation, among other things.
