Item 5.F(2) (cont.) – Discretionary advisory accounts are those accounts over which myCIO or one or more of its representatives have been named as Trustee/s which grants them the authority to make investments and/or other transactions in such accounts. In contrast, myCIO counts as non-discretionary accounts those client accounts for which the clients' signed investment advisory agreements explicitly state that the clients retain investment discretion over the assets within those accounts. For such accounts, myCIO may facilitate certain activities such as buying or selling investments, money movements, and account maintenance. Item 7.A -Affiliated Managers Group, Inc. ("AMG"), a publicly traded company, holds an equity interest in myCIO through its holding company Union Acquisition, LLC ("Union Acquisition"). AMG's equity interest in myCIO is structured so that myCIO maintains operational autonomy in managing its business. The relationship between AMG, Union Acquisition, and myCIO is defined by an operating agreement that provides that neither AMG nor Union Acquisition has the authority or the ability to operate or manage myCIO's business in the normal course. Accordingly, AMG and Union Acquisition are not "control persons" of myCIO. AMG also holds equity interests in certain other investment advisers ("AMG Affiliates"). Each of the AMG Affiliates, including myCIO, operates autonomously and independently of AMG and of each other. myCIO does not have any business dealings with these AMG Affiliates and does not conduct any joint operations with them. myCIO carries out its asset management activity, including the exercise of investment discretion and voting rights, independent of the AMG Affiliates. Except as described in this Form ADV, the AMG Affiliates do not formulate advice for myCIO's clients. In certain cases, money managers selected by myCIO may include AMG Affiliates. However, neither AMG nor any AMG Affiliate has any involvement or influence in myCIO's selection of money managers. As such, AMG's ownership interest in myCIO does not, in myCIO's view, present any potential conflict of interest for myCIO with respect to our clients. Consequently, information about individual AMG Affiliates is not listed in Section 7.A. of Schedule D of Part 1A of Form ADV. A list of all AMG Affiliates is available to myCIO's clients upon request. Item 9. In certain instances, myCIO is deemed, under federal securities laws, to have custody of certain client accounts based on the existence of standing letters of authorization ("SLOAs") authorizing myCIO to direct client assets from these accounts to client-approved third parties. In such cases, the assets of such accounts are maintained by independent, unaffiliated qualified custodians. In lieu of an annual custody examination, myCIO meets certain prescribed regulatory requirements with respect to such accounts. The number of clients with such accounts and the assets in such accounts are included in 9.A(2). myCIO is also deemed, under federal securities laws, to have custody of certain client accounts by virtue of myCIO's portfolio managers' roles as trustees to, or having a Power of Attorney over, these accounts. In such cases, the assets of such accounts are maintained by independent, unaffiliated qualified custodians and are subject to a surprise custody examination in compliance with Rule 206(4)2 under the Investment Advisers Act. The number of clients with such accounts and the assets in such accounts are included in 9.B(2), unless such clients or assets have already been included in 9.A(2). As noted above, myCIO Hedge Fund Advisors, LLC, an entity wholly owned by myCIO, is the general partner of the Funds. myCIO is deemed, under federal securities laws, to have custody of client assets by virtue of its role as the owner of the general partner of the Funds. However, myCIO does not have actual physical custody of any client assets invested in such Funds. The Funds are audited annually and investors receive annual financial statements. The Funds only hold assets of myCIO clients and each Fund invests only in a single third-party hedge fund. Accordingly, since myCIO is deemed to have custody of the portion of clients' assets invested in the Funds, and only myCIO's clients' assets are invested in the Funds, the number of clients whose assets are invested in the Funds and the amount of such assets are included in 9.B(2), unless such clients or assets have already been included in 9.A(2). To avoid double counting in 9.B(2), the Funds are not counted as clients and the Fund assets are not separately counted.
