Scott Richman is the controlling majority owner of the Adviser and serves as Managing Partner and Chief Investment Officer ("CIO"). All other partners and owners listed on schedule A are non-managing, non-voting limited partners of the Adviser. Effective November 2, 2025, Joshua Dickstein no longer works for Whitehaven Asset Management, LP (the "Adviser"). He is no longer a Control Person of the Adviser and has no role, active or otherwise in the business activities of the Adviser. However, he remains listed on Schedule A as he is still entitled to capital he is contractually obligated to receive. Therefore, he is listed as a Passive Owner on Schedule A. All Regulatory Assets Under Management reported herein are good faith estimates, subject to change upon audit. The Adviser previously had a solicitation arrangement which has since expired. However, the solicitor is still being paid consideration for its prior services. The special purpose vehicles ("SPVs") that serve as general partners and/or sponsors to the pooled investment vehicles listed in Section 7.B.1 are themselves identified in Section 7.A. as "other investment advisers" in accordance with the no-action letter to the Business Law Section of the American Bar Association (Jan. 18, 2012). Accordingly, such SPVs look to and rely on the Adviser's registration with the SEC and do not submit separate Form ADVs.
