In March 2021, George Putnam, president of New Generation Advisors, LLC ("NGA"), announced his decision to wind-down the NGA partnerships and firm.

The orderly liquidation of the portfolios and distributions to the limited partners was begun in 2021. The final distributions were made to the limited partners as of June 30, 2024. NGA’s former Chief Financial and Risk Officer, Darren Beals, left NGA in June 2021 and joined the Boston Family Office LLC full-time as its Chief Compliance Officer in July 2021. Mr. Beals is no longer an NGA Member as of December 31, 2024. He remains a consultant to NGA but as of December 2024 is no longer compensated for his services. TWO OF THOSE REPRESENTATIVES WERE RETIRED PRIOR TO 2017. THE FIRM BEGAN THE PROCESS OF REMEDYING THIS OVERSIGHT AND MAKING THE NECESSARY FILINGS WITH MASSACHUSETTS. ALL OF THE FIRM'S INVESTMENT ADVISER REPRESENTATIVES ARE NOW REGISTERED WITH MASSACHUSETTS.
