Beginning in 2019, the Advisory Account(s) were updated to clarify the minimum threshold of assets subject to the advisory or management agreement, which is used for calculation of RAUM. Included in RAUM are assets of the Pooled Investment Vehicle, MPM Macro CAV Master LP, (“MPM”) managed by Penso under an investment management agreement. Venturis Administration Ltd (“Venturis”) is registered with the CFTC (NFA ID 0505642) as a CPO to MPM but is not registered with the SEC and, accordingly, Venturis does not have an SEC file number for MPM to be included in in 7.B.(2) of this ADV. Calculations of RAUM may vary from calculation of assets under management for other purposes of the investment advisor. With respect to Schedule D. Section 5.K.(1) (2) and (3), as described above, some of the assets of certain Separately Managed Accounts (SMAs) which were previously using max risk for RAUM have now been clarified as the minimum threshold of assets subject to the relevant advisory agreement. Such Clients have full authority to maintain their investment accounts. Accordingly, we have categorized the asset type in these accounts as “other” indicating “RAUM of assets held by Client” which would consist of a combination of a number of the asset types described in 5.K.(1)(b). Additionally, the Custodians listed in section 5.K.(3) may not accurately reflect where a particular Client's assets are actually held, but rather, where assets in the amount of such Client’s RAUM is held.
