THE ONTARIO SUPERIOR COURT OF JUSTICE ISSUED A DECISION ON OCTOBER 10, 2025, DECLARING THAT PLAINTIFFS ARE PROHIBITED FROM COMMENCING OR PURSUING ANY CLAIM OF ANY KIND IN CONNECTION WITH ASSET BACKED COMMERCIAL PAPER.
